Fund Description

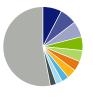
The iShares S&P Global Healthcare Index Fund (CAD-Hedged) seeks to provide long-term capital growth by replicating, to the extent possible, the performance of the S&P Global 1200 Health Care Canadian Dollar Hedged Index, net of expenses, and, to the extent possible, hedge any resulting foreign currency exposure back to Canadian dollars.

Index Description

The S&P Global 1200 Health Care Canadian Dollar Hedged Index is a float-adjusted, market capitalization-weighted index, comprised of the largest and most liquid healthcare securities from around the world. It includes all constituents of the S&P Global 1200 Index included in the Healthcare sector as defined by the Global Industry Classification Standard (GICS®), the most widely used industry classification in the world. The index is currency hedged to Canadian dollars. The S&P Global 1200 Health Care Canadian Dollar Hedged Index is defined using the Global Industry Classification System (GICS®). The major sub-sectors are pharmaceuticals, health care equipment and biotechnology.
