The iShares Dow Jones Canada Select Growth Index Fund (XCG) seeks to provide long-term capital growth by replicating, to the extent possible, the performance of the Dow Jones Canada Select Growth IndexSM, net of expenses.

Index Description


The Dow Jones Canada Select Growth index covers only the large-cap and mid-cap portion. The index is weighted by float-adjusted market capitalization, subject to a 10% cap on the weight of individual securities. The stock's style classification is determined based on a multifactor model that accounts for: Projected Price-to-Earnings Ratio (P/E), Projected Earnings Growth, Price-to-Book Ratio (P/B), Dividend Yield, Trailing P/E and Trailing Earnings Growth.
