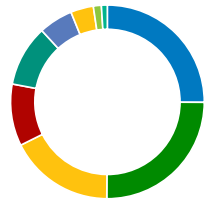

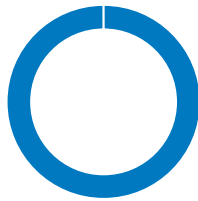

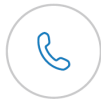
Geographic Allocation

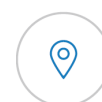
